## Data Protection

The Bella IG collects personal information of participants for the purpose of preparing and organising the yearly meeting. Data concerning reservations on camping places will be shared with the camping ground operators. Other than this, information will not be provided to any third parties. Data will be destroyed as soon as it is no longer required for its intended purpose and law and regulation allows. Requests into information held can be made free of charge. For questions and instructions in relation to destruction, correction, blocking, survey, processing and use of information can be sent by participants to the organizer of the yearly meeting by using the address below.

## Photo and video recordings

The participants inclusive of riders, co-riders, children, vehicle owners and holders declare that through completing the registration form that they agree to the conducting of photo and film works during the event, as well as granting the free broadcast, public reproduction, recording, copying and editing rights with respect to the film or photo recordings made of their person, any accompanying persons or their vehicles. These rights extend to the use of recordings for the purpose of self-promotion, event promotion and the use by sponsors and event partners.

Not only the organisers, but also the participants and spectators have a justified interest in taking photo and video recordings of the event and to make these public in certain circumstances. Should you insist that you are not included in any recordings of participants, organisers or spectators, we can regretfully only suggest not to attend the event. Of course, you can let the organisers know upon your arrival that you would prefer not to be included in any recording. Should you only discover after the event that recordings have been made that you prefer would not be made public, you can still contact the organisers. However, we have no influence over recordings made by any third party, nor can we influence the reporting on the event by news agencies or magazines.

## Liability and participants regulations

The participants (riders, co-riders, children, vehicle owners and holders) partake in the event at their own risk and through submission of the registration form waive for them and those in their care the liability as well as every right of action and recourse towards the organisers, those acting on their behalf, authorities or those connected to the event in relation to accidents and damages when not the result of gross negligence or intent. Participants bear the civil and criminal liability for any and all damages caused by them or their vehicles. Participants should at all times adhere to traffic rules and regulations.

The waiving of liability commences with the return of a signed participation form. The prerequisite for participation in the event is the signed and completed registration form inclusive of payment of the registration fee. The organisers can reject any registration without justification. Should any provision in this registration be ineffective or inappropriate, this will not affect any other provision. In case of any inconsistencies the german version of the registration shall prevail.
